

S pring is on the horizon, and with its arrival comes preparation for our 86th Annual Meeting. Join us for this year's business meeting on Saturday, April 27. Members can attend the meeting in-person at either the Ladysmith headquarters warehouse or the Hayward outpost.

Registration begins at 9:30 a.m. with the business meeting starting at 10 a.m. Members attending at both locations will be able to participate in all aspects of the meeting, from voting to winning prizes. As a way of saying thank you for attending, members will receive a door prize and a \$25 energy credit, plus they will have a chance to win a \$500 energy credit during the meeting.

Voting options remain the same as last year. Members can cast their ballot electronically (web), through absentee voting, or in person before the annual business meeting. 8 things all homeowners should do to lower their energy bills

Tuesday, March 19, marks the spring equinox and the end of the coldest days of winter. With the start of a new season comes a fresh opportunity to find ways to save energy and money. Keep in mind that an investment in energy efficiency not only saves you money on your energy bill, but it may also qualify for an Energy \$ense rebate through JREC.

Install and set a programmable thermostat.

You can save money on your heating and cooling costs by simply resetting your thermostat when you



are asleep or away from home. A programmable thermostat allows you to do this automatically without sacrificing comfort. *Rebates Available*

Switch to ENERGY STAR[®] appliances, fans, and electronics.

Using Energy Star^{*} certified products throughout your home are life-cycle cost-effective. Most products provide energy guides, but not all are ENERGY STAR^{*} rated. *Rebates Available*



Use an electronic power strip. Help reduce phantom loads and save all year by plugging

electronic devices into a power strip that is turned off when not in use.



Maintain your heating and cooling system.

Check and replace your air filters regularly and arrange

for annual maintenance with a qualified technician. Check your duct system as about 20 to 30 percent of the air that moves through this system is lost, resulting in higher utility bills.





Use window treatments to your advantage. About 30 percent of a home's heating energy is lost through

windows. In cooling seasons, about 76 percent of sunlight that falls on standard double-pane windows enters to become heat. In the winter, open coverings in morning to allow the sun to heat your home through the day. In the summer, keep coverings closed to reduce solar heat gain. For natural

light, open window coverings that don't get direct sunlight.

Choose energy-saving lighting.

Lighting accounts for around 15 percent of an average home's electricity use. The average household saves about \$225 in energy costs per year by using LED lights. For the greatest energy savings, choose bulbs that have earned the ENERGY STAR rating. *Rebates Available*



Reduce energy for water heating.

Take simple steps like lowering your water heater's temperature and installing low-flow showerheads. JREC sells electric water heaters and rebates apply if placed on the load management program.

Consult a home performance contractor to achieve large savings.

These professionals will do a comprehensive audit of your whole house using special tools to measure home energy efficiency.



Rebate Available: \$150 towards cost of a home energy audit, plus up to \$500 on recommended efficiency improvements made.

A summary of available rebates is listed to the right. Go to jrec.com/energy-sense-rebates for rebate forms and the entire list of available rebates and qualifying guidelines per category. Rebate requests need to be submitted within three months of either the purchase or installation. Be sure to cash in on these rebates in 2024.

Trees beautify our neighborhoods, our homes, and when planted in the right spot, can even help lower energy bills. However, the wrong tree in the wrong place can be a hazard.

As you plan your tree and landscape plantings, consider that trees and shrubs need space to grow both above and below ground. Reduce fire hazards, power outages, and the need for frequent pruning with proper selection and planting of trees near utilities. You can find



more on how to plant the right tree in the right place at jrec.com/row-maintenance. Remember to also call Diggers Hotline (dial 811) at least 72 hours before you begin any digging project.
