ELECTRIC VEHICLE (EV) CHARGER AGREEMENT

This agreement was executed this _____ day of _____, 20____, between Jump River Electric Cooperative, Inc., a corporation organized under the Laws of the State of Wisconsin, (hereinafter referred to as the “Cooperative”) and the above-named Owner/Member.

WHEREAS, it is in the joint interest and benefit of the named parties to conserve the use of electrical energy and to minimize the cost of electrical energy sold and delivered by the Cooperative to the Owner/Member.

NOW, THEREFORE, it is hereby agreed by and between the parties as follows:

1. The EV rate schedule is available to members utilizing either a ZEF Level 2 EV charger or any other Level 2 EV chargers that agrees to have their load interrupted each weekday by a receiver provided and installed by the Cooperative.
2. There is an EV fixed cost of delivery charge per month per EV Charger. There is no sales tax added from November through April for farm and residential use (Wisconsin residents only).
3. EV chargers on this rate schedule shall be interruptible.
4. To be eligible for this program, the service needs to be a Single-phase, sixty (60) Hz, at available secondary voltages.
5. All Level 2 EV chargers should be wired on their own dedicated circuit.
6. ZEF Level 2 EV Chargers: These chargers will be metered and interrupted by built in components utilizing a cellular or Wi-Fi connection.
7. All other Level 2 EV Chargers: The Owner/Member agrees to have a receiver installed on the equipment. Jump River Electric Cooperative will install the receiver within 30 working days from notification of EV charger installation
 - a. The Owner/Member will make provisions in their electric wiring for a receiver and will provide all other wiring, equipment, and installation; including a relay or contactor and a double pole breaker, or a Cooperative approved relay panel, which shall be rated at least total load capacity.

- b. The Owner-Member agrees not to utilize the EV meter for any load other than the EV charger.
 - c. The EV charger must be mounted on an **exterior wall** to allow the meter and receiver to be installed on the outside of the structure, permitting access to Cooperative personnel.
 - d. The meter will be installed by the Cooperative and record the EV charger load separately from the general-purpose meter and may be a subtractive meter.
 - e. The Cooperative shall furnish the receiver and all wiring materials for connecting the receiver, which shall remain the property of the Cooperative.
8. The Cooperative reserves the option to remove their equipment and materials at its discretion.
 9. The Owner/Member agrees to allow the Cooperative to periodically inspect the Owners/Members premises to monitor electric energy usage and inspect its equipment.
 10. Problems occurring with an interrupted load shall be analyzed and corrected by an electrician and the Cooperative will reimburse the Owner-Member for reasonable service calls if the problem was due to the receiver.
 11. Non-compliance with this agreement or any tampering with the Cooperative's equipment shall invalidate this agreement and the Owner/Member will be subject to the Cooperative's policy regarding this matter.
 12. The Owner/Member do hereby release, discharge, agree to indemnify, assume sole responsibility, and hold harmless the Cooperative from liability for any injury or damage to the person(s) and/or property of the Owner/Member, or any trespasser on the Owners/Members property resulting from the use of, directly or indirectly, said receiver excepting only and such injury or damage resulting from the willful act of Cooperative's representatives, agents, or employees.
 13. If the receiver system is removed from the Owners/Members premises, the Cooperative will not be responsible for repairing screw and drilled holes, discoloration, or damage to buildings.
 14. The undersigned hereby certifies and agrees to the conditions as described herein.
