Purpose of Notice

The purpose of this notice is to invite nominations of members residing in District 9 as candidates for director at the annual election of directors.

Nomination of Directors

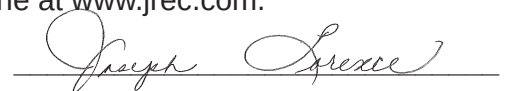
As stated in Article IV, Section 4: Nomination of Directors: Any 15 or more members of the district from which a director is to be elected at the succeeding annual meeting may make nominations in writing over their signatures, not less than 60 days prior to the annual meeting. In the event no nominations are submitted for any district by that date, the Board of Directors shall appoint a Nominating Committee which shall exercise reasonable efforts to nominate two or more qualified candidates for director from that district.

How to Become a Director Candidate

- Use the **Petition for Director Nomination** form located on the back of this notice.
- Obtain signatures from **15 or more members residing in District 9**.
- Return the completed petition to the Cooperative office **on or before February 24, 2026**.

Additional Information

- In accordance with the bylaws, any member organization (town or school board, community club, civic group, etc.) must designate in writing their representative to the meeting. Such written designation shall be filed with the secretary at or before the Annual meeting. Such representatives may also vote as individuals if they are members.
