



MEMBER REFUND FROM NUCLEAR SETTLEMENT

As we approach the holiday season, we are thrilled to share some exciting news with you. At Jump River Electric Cooperative, we are committed to providing reliable, safe, and affordable electricity to our members, and we are always looking for ways to give back to the members we serve. In that spirit, we are pleased to announce that a refund will be issued to eligible members this December, thanks to a successful settlement that our wholesale provider, Dairyland Power Cooperative, reached for the spent nuclear fuel storage from the La Crosse Boiling Water Reactor site.

Understanding LACBWR

The La Crosse Boiling Water Reactor was a nuclear power facility located near Genoa, Wisconsin. It began operations in 1967 and was an integral part of

our energy generation portfolio for many years. In 1987, the reactor was permanently shut down, and Dairyland Power Cooperative started the process of safely decommissioning the facility.

As part of this process, Dairyland is obligated to store the spent nuclear fuel in concrete casks to meet safety and regulatory standards. Recently, Dairyland reached a settlement with the government to cover some of these storage expenses.

A Holiday Refund for Our Members

We understand that the holiday season can be a time of increased expenses, and we hope that this refund will provide some financial relief and add a bit of cheer to your celebrations. The settlement refund of \$187,932.26

will be passed back to active members based off your 2019-2022 usage and will be applied to eligible accounts on your December billing statement. This refund is a testament to the cooperative spirit that defines us. It reflects our ongoing commitment to serving you with integrity, transparency, and a focus on you, the member-owners.
