COMMITMENT TO GRID RELIABILITY FUELS CHANGES TO LOAD MANAGEMENT

To help ensure electricity is available year-round and reduce the amount of energy we need to purchase when prices are high, Midcontinent Independent System Operator (MISO), the regional grid operator, has changed their requirements for Dairyland Power Cooperative, our wholesale power provider. This has resulted in modifications to our load management program.

Residential electric water heaters and auto-start generators enrolled in the load management program will no longer be part of the Peak Alert/Full Load Control schedule. Instead, they will be managed in the following situations:

- During a Maximum Generation (Max Gen) Event—a maximum of 16 times per year and no less than four times per year (once each season).
 - A Max Gen Event can be declared at any time of the year. Participants will receive a notice at least two hours before their devices are managed.
- Enrolled water heaters will still participate in economic control events when electricity prices are high in the MISO market, and local reliability events.

New this winter season, full load control events will be split into morning and evening events from December through February. A review of electricity peaks in the MISO system revealed that 60 percent of peaks occurred in the morning. To successfully reduce our electricity needs during the time of highest demands, electric heat units enrolled in the dual fuel load management program will be managed in the mornings, beginning at 6:55 a.m., with restoral starting at 10:05 a.m. Enrolled dairy water heaters, grain dryers, and manual standby generators will remain on the traditional winter schedule of 4:55 p.m., with restoral beginning at 8:05 p.m. Electric Thermal Storage (ETS) units will not be affected by this full load control schedule change.

Jump River Electric Cooperative has successfully managed

our load management program for many years. Through voluntary member participation, we reduce our need for electricity during times of high demand and high electricity prices, which benefits all cooperative members. Members who are enrolled in the dual fuel or ETS load management program receive a special off-peak energy rate. In the event of a full load control event, JREC will notify members on Facebook and through radio announcements.

BE SAFE DURING THE HOHOHOHOLDAYS 10 TIPS TO HELP YOU STAY JOLLY

Before you plan out your new holiday lighting scheme or repeat last year's festive design, keep these 10 safety tips in mind when decorating outdoors:

> Do not toss light strands up into the air. They could get too close to or come into contact with a power line.

😥 MY CO-OP

Before using a ladder, always look up and assess all power line locations.

Carry a ladder horizontally when transporting it.

Keep at least 10 feet between yourself (and any item you are holding) and a power line.

Do not use staples or nails or tacks to secure light strands, cords, wires or extension cords.

String together no more than the number of strands recommended by the manufacturer.

Plug all lights and extension cords into GFCI-protected outlets.

Use lights and extension cords rated for outdoor use.

Do not use frayed, cracked or otherwise damaged cords, plugs or lights.

Use only lights and products certified by a reputable testing lab.
