DO YOU HAVE A BACKUP PLAN?


It's impossible for JREC to guarantee uninterrupted power as outages occur due to a variety of reasons. We all need to have a backup plan, but it is especially important for those who depend on life-support equipment. Your backup plan should include:

- Obtain a backup source of power recommended by the manufacturer of any critical care equipment.
- Keep a full charge on battery-operated devices or have extra batteries on hand and check these batteries periodically.
- Keep your cell phone charged and be sure this number is also listed as your primary contact number with JREC.
- Complete and mail in (or call) the life-support equipment form below so JREC is aware of your needs.
- Have a plan of where you can go in the event of a long-term outage.

STATEMENT OF **NONDISCRIMINATION**

Jump River Board Abbreviated Minutes

The regular board meeting of Jump River Electric Cooperative, was held in person at the Ladysmith Headquarters on Tuesday, February 23, 2021, at 9 a.m.

January minutes, financials, member applications, member refund list, outages, board expense and general manager reports were submitted to the board of directors to review prior to the start of the meeting.

January Minutes – A motion was made, seconded and unanimously carried to approve the January minutes as amended.

Safety Report - Director Jane Reich discussed the need for taking personal responsibility, not taking shortcuts, and keeping workspace clean and clear for safety purposes.

Operations Update - Kurt Harris, general foreman, reported on the progress of mowing and brushing, mapping, pole changes, asset management, and new barcode inventory system. Exhibit 2-21-1, Holding the Current Pricing for Aid of Construction, was presented and reviewed. A motion to approve was made, seconded, and unanimously carried. Harris presented on fuses placed on transformers to prevent multi-unit outages during animal interference. Engineer McCabe presented on voltage regulator projects. A motion was made, seconded, and unanimously approved to accept the operations report.

General Manager's Report - Anderson reported on Current Energy Crisis in Southern States, Strategic Planning Objectives, S.T.E.M. Panel, Community Cents, Dairyland Power, and Annual Meeting.

Executive Session – A motion was made, seconded, and unanimously carried to enter into Executive Session.

Out of Executive Session - A motion was made, seconded, and unanimously carried to come out of Executive Session.

Action Resulting from Executive Session - None.

A motion was made, seconded and unanimously approved to accept the General Manager's Report.

Financial Report – Lori Davis, finance manager, reported on the check register and investments. Davis reported that the independent audit is complete, and a full report is forthcoming. A motion was made, seconded, and unanimously approved to accept the financial report.

Dairyland Power Cooperative Director Report – Director Jane Reich reported that during the January DPC board meeting, the BOD Cooperative's Board of Directors approved membership dues, Whitehall load management property, power supply work construction plan, and 2020 year end margins. A motion was made, seconded, and unanimously carried to approve the Dairyland Director Report.

A thank you note was passed around to the directors from The Foundation for Rural Housing.

New Business - Items up for discussion included community room, NRECA Annual Meeting, NRECA Director Conference, for the good of the cooperative, donation request, and March meeting date.

March meeting date was set as Tuesday, March 30, 2021 at 9 a.m. at the Ladysmith Headquarters.

Executive Session - A motion was made, seconded, and unanimously carried to enter into Executive Session at 12:30 p.m.

Out of Executive Session - A motion was made, seconded and unanimously carried to come out of Executive Session at 1:36 p.m.

Action Resulting from Executive Session - None.

Adjournment – Chairperson Brooks adjourned the meeting at 1:51 p.m.
