CAPITAL CREDITS

Your piece of the pie!


In November, you will receive your slice of the over \$509,000 in capital credits being refunded in 2020. Capital credits are just one piece that sets Jump River Electric Cooperative (JREC) apart from investor-owned utilities. Each co-op member is an owner and because electric co-ops operate at cost, any excess revenues, called margins, are returned to members in the form of capital credits. The graphic at right explains how this co-op benefit works.

Recently, the board of directors approved retiring 100 percent of any capital credits *allocated in 1990 and an additional 2.5 percent of allocated capital credits from the years 1991 to 2019. These capital credits will be applied to active members' energy bills in November. Inactive members who have a **retirement of \$10 or more will receive a check in the mail this December.

Over the years, your co-op has returned just over \$8.8 million in capital credits. This is proof that co-op membership pays off!

If You Move off JREC power lines, please be sure to notify us of any address changes so we can continue to refund any capital credits you are eligible to receive in the future.

In the Event of Death, the capital credit account is available for estate retirement. The representative of the estate should contact JREC to settle the capital credit account.



***Allocation**—Your share of the amount of net margins JREC sets aside into a separate account to be used as operating capital for reliability improvements and maintenance over a period of years. You received notice of this allocated amount earlier in the year.

****Retirement**—The amount you receive back as a capital credit refund. This amount is a percentage of your total capital credit balance.



INTERRUPTIBLE HEAT TEST SET

On Wednesday, November 18, residential electric heating on our dual fuel program will be interrupted for a test of the load management system. The test will begin at 5 p.m., with all electric heating to be restored by 10 p.m. If everything is working properly, a yellow light will be visible in the window of the load management receiver. If your electric heat remains on during the test, or if you experience any other problems, please contact our office at 715-532-5524.

Reducing your consumption between the hours of 5 to 10 p.m. on the coldest winter days will reduce the number of peak alerts and dual-fuel electric heat interruptions. This also helps the cooperative save on our wholesale power bill, and this savings is passed along to you.

SAFETY – NO. 1 PRIORITY DURING YOUR HUNT

Nearly 600,000 hunters will soon be heading into Wisconsin’s woods, fields, and marshes for the state’s nine-day gun deer season. Incidents resulting in serious injury during the hunting season can happen when hunting from the ground or

a tree stand. According to the Wisconsin Department of Natural Resources (DNR), tree stand falls are outpacing gun-related injuries and deaths for hunters.

We encourage all members, even experienced hunters, to review the following firearm and tree stand safety tips before heading out into the woods this hunting season. As you are looking for your 30-point buck, be aware of electrical equipment and take necessary precautions while hunting. Keep all these safety tips in mind as you enjoy the great outdoors.



ELECTRICAL SAFETY TIPS FOR HUNTERS

This hunting season, we encourage all members to be aware of electrical equipment and take necessary precautions while hunting. Keep these safety tips in mind as you enjoy the great outdoors.



Take notice of posted warning signs and keep clear of electrical equipment.



Do not shoot at or near power lines or insulators.



Know where power lines and equipment are located on the land where you hunt.



Be especially careful in wooded areas where power lines may not be as visible.



Do not place deer stands on utility poles or climb poles. Energized lines and equipment can conduct electricity to anyone who comes in contact with them, causing shock or electrocution.



Do not place decoys on power lines or other utility equipment. Any non-electrical equipment attached to a pole can pose an obstruction and serious hazards to our line crews.

Rules of Firearm Safety

Knowing the basic rules of firearm safety is essential.

- Treat every firearm as if it is loaded
- Always point the muzzle in a safe direction
- Be certain of your target and what’s beyond it
- Keep your gear in good working order
- Inspect your clothing and other equipment for signs of wear and tear
- Transport guns safely

Tree Stand Safety

- Climb and hunt sober
- Always check the condition of your tree before you climb
- Test the hardware
- Get a full-body fall restraint harness
- Attach an extra foot strap to your fall-restraint harness
- Exercise caution when climbing or descending and when climbing in and out of your tree stand or platform
- Use a short tether
- Use a haul line
- Have a recovery and escape plan
- Make sure you can communicate


